

TERMS AND CONDITIONS

1. Detailed description of goods and/or services

Reticulation Network Management (Pty) Ltd is a business in the electricity industry that provides metering of electricity consumption and sell electricity on behalf of their client(s) to home/property owners/tenants.

2. Delivery policy

On receipt of successful payment, the order will be processed immediately, displaying the electricity token and detailed receipt. Confirmation can be sent by email to the registered email address of the customer and if desired, the electricity token will be sent by SMS to the registered mobile number.

3. Return and Refunds policy

Reticulation Network Management (Pty) Ltd cannot refund any payments. If a payment is verified and an electricity token not generated, we will manually generate a token with units in kWh per tariff applicable.

4. Cancellation policy

When a transaction is cancelled by the customer before payment is done or the transaction is cancelled by the bank for any reason, a token will not be generated and the customer should commence a new transaction.

5. Customer Privacy policy

Reticulation Network Management (Pty) Ltd shall take all reasonable steps to protect the personal information of users. For the purpose of this clause, "personal information" shall be defined as detailed in the Promotion of Access to Information Act 2 of 2000 (PAIA) and in the Protection of Personal Information Act, 2013 (Act 4 of 2013).

7, Card acquiring and security

Card transactions will be acquired for Reticulation Network Management (Pty) Ltd via PayGate (Pty) Ltd and Instant EFT transactions via Setcom (Pty) Ltd trading as SiD Secure EFT, a DPO Company, who are the approved payment gateways for all South African Acquiring Banks. They use the strictest form of encryption, namely Transport Layer Security (TLS 1.3) and no Card or Internet banking details are stored on the website. Users may go to www.paygate.co.za to view their security certificate and security policy.

8. Customer details separate from card details
